- 7. Conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of the Richland Middle School parent and family engagement policy

in improving the academic quality of Richland Middle School. We will use the findings to design strategies for more effective parent and family engagement and to revise, if necessary, its parent and family engagement policy.

Parent Engagement Evaluation

Each spring, Richland Middle School will assemble a team, including Title I parents, teachers, and staff members, to review the content and effectiveness of their family engagement policies and programs. Evaluation information will be collected through parent surveys that gauge levels of family engagement while identifying barriers to parent participation. Based on this input and through a collaborative consultation process, the campus will review the existing family engagement policy and make revisions as necessary.
